  - **Start date is Tuesday November 15th**
  
- **All images are due in the repository by 12:00 p.m. Friday December 2nd.**  
**PLEASE review submitting veterinarian instructions.**
  
- **The Repository will be open for viewing:**
  - Sunday, December 4<sup>th</sup> from 12:00 p.m. to 5:00 p.m.**
  - Monday, December 5<sup>th</sup> from 8:00 a.m. to 5:00 p.m.**
  - Tuesday, December 6<sup>th</sup> from 8:00 a.m. to End of Sale**
  
- **SCOPING VIDEOS must be performed no earlier than 10 days from the actual date the horse is sold. PLEASE STATE THE HORSE ID CREDENTIALS AT THE COMMENCEMENT OF THE VIDEO RECORDING.**
  - **Scope video start date is Saturday November 26th**
  
- **ALL X-RAYS, REPORTS, DOCUMENTS AND SCOPE VIDEOS SHOULD BE SUBMITTED THROUGH ASTERIS.**

### SUBMITTING A STUDY

To [submit a study online](#), please login to the Keystone Community Website. If you have not submitted x-rays before, you will need to register using the link above. You can queue many studies via the DICOM service and then submit them as appropriate to each hip.

If you are using Asteris Keystone at your veterinary practice, you may skip this step and find an option in the Asteris Clinic management software to upload instead. For further information about using this feature, please [contact Asteris](#).

### LABELLING

It is important to label your study as accurately and completely as possible. When submitting a set of x-rays please be sure to complete the following in your software.

Accession Number/DICOM Tag Requirements – A combination of the sale code and the lot number in 4-digit format as per the following examples.

**Patient ID = FTMYYMM-XXXX**

M = First letter of state in which sale is held

YY = Last two digits of the sale year

MM = Month of the sale

XXXX = Full hip number including leading zeros

Examples:

**2022 Midlantic Two-Year-Olds in Training Hip 44 = FTM2205-0044**

2022 Midlantic Fall Yearlings Hip 400 = **FTM2210-0400**

2022 Midlantic December Mixed Hip 250 = **FTM2212-0250**

**Patient Name:** Horse's Name OR Dam and last 2 digits of Year of Birth (YOB)

Example: **SPRING DANCE 21**

The name of the veterinarian or clinic, date, sex and microchip (if available) are also required to appear in the study; no specific formatting is required.

**OVERLAYS**

Please export your studies **WITH burnt in overlays on images**. Our DICOM viewing software has the option toggle the most relevant tags on/off when viewing. In addition, there is a button to view all tags.

**REQUIRED VIEWS**

[AAEP Minimum Required Views](#)

To accommodate viewing sort order all hips must be submitted with the anatomical/view information. You may have to contact your equipment representative to arrange this formatting.

**ALL REPORTS**

All reports must be submitted in **PDF format** through Asteris. They should be submitted along with the x-rays where possible, and at least four (4) days prior to the start of the sale. The veterinary report will no longer be made available for review at the repository. The x-ray report must also disclose attending veterinarian's ownership interest in the subject horse, if any.

**SCOPING VIDEOS (OPTIONAL)**

**Scoping videos must be performed no earlier than 10 days from the actual date the horse is sold.**

Recommended file size: There is a 100MB limit to video file size. For ease of viewing, it is recommended that file sizes be kept within reason. Supported file types: \*.asf, \*.avi, \*.mov, \*.mp4, \*.mpeg, \*.mpg, \*.wmv

Please **state the horse ID credentials** at the commencement of the video recording.

All video scopes should be submitted through Asteris.

The videos can be viewed on-site and remotely.

**HANGING PROTOCOLS**

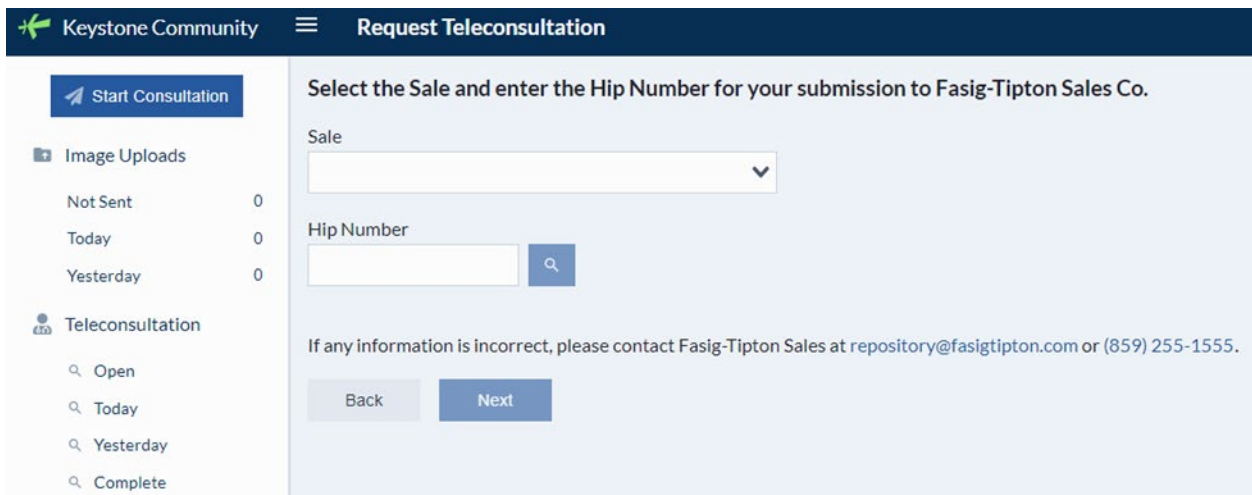
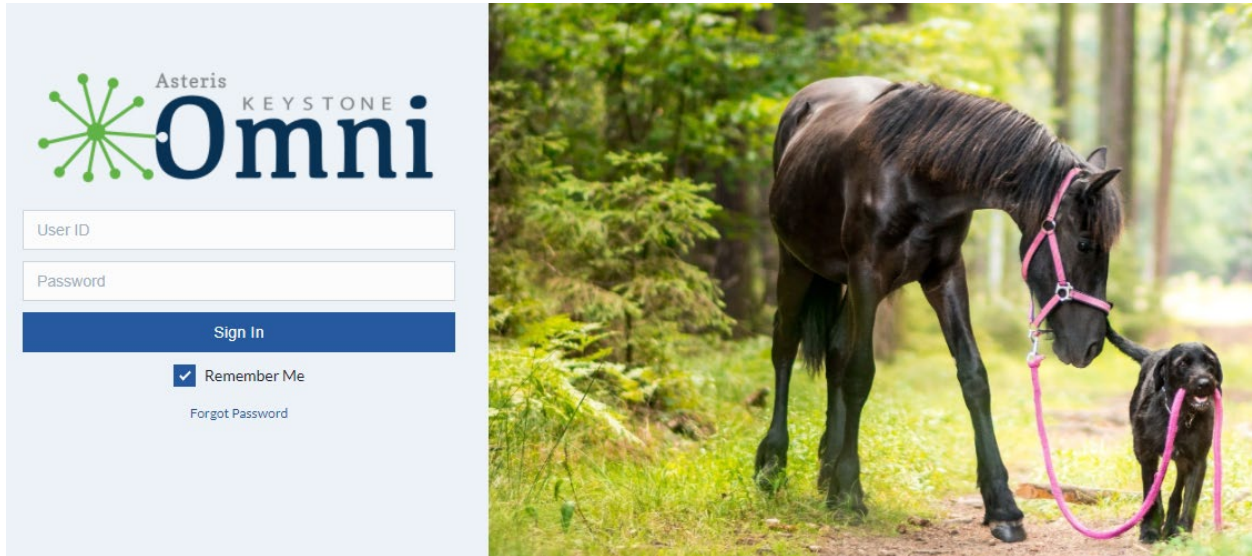
Our system is hanging protocol aware and can be customized depending on how effectively the anatomy of the horse can be identified during uploading of the study. If you want the viewing vet to be able to adjust the hanging protocol used, we recommend you upload your study and match any images which can't be automatically identified.

Uploading your own studies online allows the submitting vet full control over the process and more accuracy as the automatic options do not always match perfectly.

If you have an x-ray machine that is new to market or recently updated, please encourage your machine vendor to contact Asteris so they can work with the vendor to automate the hanging protocol detection system in their software. It is advisable to submit a sample set of x-rays before a sale to help eliminate potential problems.

**REPOSITORY ACCESS**

Access is restricted to registered vets for the purpose of examining a set of x-rays for a potential buyer or submitting x-rays taken on behalf of a consignor for a horse in the sale.

Details will be provided upon registration for repository access.

A username and password are required for viewing x-rays. Credentials for submission are different from credentials for viewing.


**TECHNICAL INFORMATION**

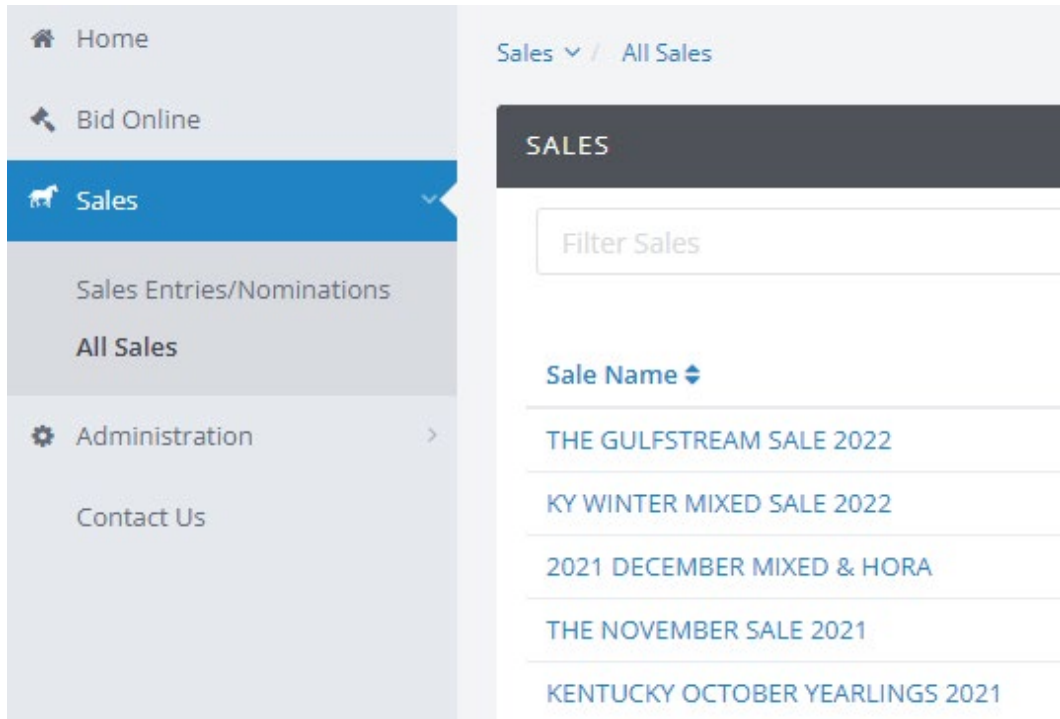

- All x-rays submitted to the repository must be accompanied by a veterinarian x-ray report. This report will be date & time stamped following the approval process and will be made available to the consignor in the Fasig-Tipton Client portal. [Client Portal](#).
- The report will no longer be made available for review at the repository; interested parties must obtain the report directly from the consignor. The x-ray report must also disclose attending veterinarian's ownership interest in the subject horse, if any.
- Consignors can review their Repository submissions & activities via the [Client Portal](#).
- The repository system displayed in the [Client Portal](#) will include both remote and on-site activity.
- Consignors may add as many individual users to their [Client Portal](#) account as necessary.
- Each individual user will be able to customize the text/email alerts they would like to receive, relating to repository activity as well as many other aspects of their consignment.
